

Chicago Chesed Fund 2022 Tesla Raffle Official Rules & Regulations

You are responsible for reading these official rules and regulations. The Tesla Raffle Drawing will be held on Monday evening, September 5, 2022. The drawing is limited to a maximum of 9,999 entrants. The odds of winning depend on the number of tickets sold. The Grand Prize winner will choose to receive either

(1) His or her choice of a 2021/2022 Tesla Model S (herein after “Tesla”), a 2021/2022 Tesla Model 3, 2021/2022 Tesla Model X, 2021/2022 Tesla Model Y, or a Tesla Cybertruck when it becomes available (collectively referred to as the “Tesla Grand Prize”); or

(2) An “Alternate Grand Prize” of a certified check in the amount of \$50,000.00 USD.

These prizes are the only prizes that can and will be offered.

The Tesla Grand Prize shall be the winner’s choice of a Tesla Model S, a Tesla Model 3, Tesla Model X, Model Y, or a Tesla Cybertruck when it becomes available. The Tequila Prize winner will receive: A bottle of Tesla Tequila, value approximately \$1,500.

Tickets will be awarded on a one-to-one basis to all Tesla Grand Prize Raffle ticket purchasers for the number of tickets purchased for the Tesla Grand Prize Raffle. These entries will be placed into a pool independent of the Grand Prize Drawing. The deadline for ticket entries will be at **Monday, July 11, 2022 at 11:59 pm**.
